


## Small Group Framing: Why are we here?

- Establish a Health Care Contracting Strategic Planning team
- Determine internal resources needed to implement Community Health Integration (CHI), Principal Illness Navigation (PIN) services and billing codes
- Seek multi-payer alignment to a single model of care to address Health Related Social Needs (HRSN) that incorporates social care
- Secure pilot funding
- Identify a billing and claims management system
- Develop marketing tools for provider recruitment
