









# Map of NLC Participant Representation

# Opportunities to Align Health and Social Care

- Increased attention on social drivers of health (SDOH)
  - HHS SDOH Action Plan and ongoing inter-agency coordination
  - Medicaid 1115 Waivers in AR, AZ, CA, MA, NJ, OR, WA supporting state investments to address health-related social needs (HRSNs)
  - CMS rules: New screening measures for SDOH for hospitals, physicians and Special Needs Plans + new <u>Advanced Payment Incentives for Medicare ACOs</u>
- Need to ensure capacity exists within communities to effectively partner with health care to address HRSNs, respond to increase in referral volume
- Community-based organizations (CBOs) are increasingly contracting with health care organizations to address health-related social needs (<u>Aging and Disability Business Institute 2021 Request for Information</u>)
  - Leverages CBO core competencies and services
  - Percentage of CBOs contracting as part of a network doubled between 2017 and 2021, from 20% to 40%

# Collaboration is Key

- Great expertise and experience among NLC participants – peer based learning is essential to growth of Hubs
- Encouraging collaboration within and across participating states
  - Many organizations have already come together to develop Hub capacity and grow health care partnerships
  - Identify most efficient Hub operating model within a region and collaborate across organizations to achieve those efficiencies
  - Ensure hubs are making smart investments
    - Opportunity for shared costs and services
    - Reduce duplicate expenditures

# Partnership to Align Social Care

- Opportunity for NLC participants to benefit from national multi-stakeholder collaboration:
  - Identifying core competencies and an approach for qualifying CBO networks;
  - Encouraging widespread use of core billing codes;
  - Developing a streamlined contracting process between health systems, payers, and CBOs;
  - Promoting common IT security and interoperability standards;
  - Enabling organization and financing strategies for sustainable CBO network infrastructures and lifting up current best practices among CBO networks; and
  - Producing a framework that reflects a balanced, common vision for achieving and sustaining an "ideal state" of health and social care alignment.



# National Learning Community: CCH Definition & Purpose

#### What is a Community Care Hub?

- A community-focused entity that organizes and supports a network of community-based organizations providing services to address health-related social needs. A Community Care Hub centralizes administrative functions and operational infrastructure, including but not limited to, contracting with health care organizations, payment operations, management of referrals, service delivery fidelity and compliance, technology, information security, data collection, and reporting.
- A Community Care Hub has trusted relationships with and understands the capacities
  of local community-based and healthcare organizations and fosters cross-sector
  collaborations that practice community governance with authentic local voices.

#### NLC Purpose:

To bring together organizations serving as Community Care Hubs (CCHs) that are either in development or interested in expansion to take part in shared learning, information and resource sharing, and coordinated technical assistance with the goal of building the strength and preparedness of the CCH to address health-related social needs and public health needs through contracts with health care entities.

# National Learning Community: Aims & Objectives

#### Aims

- Build the collective strength of CCHs through peer-to-peer learning and information and resource sharing, as well as engagement with subject matter experts
- Develop and expand CCH capacity across the country, including areas without existing CCH infrastructure, to connect more individuals to person-centered, coordinated supports to address social drivers of health
- Address public health needs and leverage relevant public health expertise in a community through collaboration with local public health leaders

#### Objectives

- Broaden the geographic coverage and capacity of CCHs through a national effort targeting community-based organization network development and expansion
- Employ diversity, equity, and inclusion strategies, as well as leverage public health and other available community data, to evolve network composition to ensure services and providers are reflective of the communities served and their priorities

# Learning Tracks

#### **Network Development**

- Led by USAging's Aging and Disability Business Institute
- Curriculum focuses on foundational building blocks of establishing a Community Care Hub
- CCH Capacity Assessment to inform strengths and areas to focus technical assistance efforts

#### **Network Expansion**

- Co-led and facilitated by peers and subject matter experts
- Curriculum focuses on
  - Enabling partnerships with housing and other SDOH partners,
  - Billing, coding and payment; and
  - Exploration of shared resources and services, with a focus on IT
