

Through it, we are interested in improving access to and knowledge of vaccination against COVID-19 in the study's population, by means of implementing evidence-based health literacy strategies.

All information you provide to us as representative of an entity or organization, will be important for developing educational resources on COVID-19 vaccination, tailored to communities' needs. To participate in this study, you must:

- 1. Provide services or support in the COVID-19 vaccination process to the population of adults aged 60 and over.
- 2. Be established in the identified areas in Puerto Rico (Añasco, Cabo Rojo, Cataño, Ceiba, Guánica, Loíza, Luquillo, Maricao, Naguabo, and Salinas).
- 3. Be 18 years old and over.

This assessment consists of 22 questions distributed in the following sections:

- 1. General Perception About the COVID-19 Vaccination Process
- 2. Barriers in the COVID-19 Vaccination Process in Adults 60 Years and Over
- 3. Health Literacy
- 4. Participant Profile

To participate in this study, you must provide services or support in the COVID-19 vaccination process (for example, doctors who offer guidance on vaccination; healthcare professionals who prepare and/or administer the doses, and offer guidance on the vaccine; customer representatives, among others) provide services or support to the population of adults 60 years and over, be established in the identified areas in Puerto Rico (Añasco, Cabo Rojo, Cataño, Ceiba, Guánica, Loíza, Luquillo, Maricao, Naguabo, and Salinas) and be 18 years and over.

This assessment is completely confidential. Information that might identify you as an entity, organization or community leader will not be published. The responses submitted will be used exclusively by team members of the *Puerto Rico COVID-19 Health Literacy Initiative*. A four-digit identifying number will be used with the purpose of safeguarding the participant's identity and confidentiality. These responses will be safeguarded by the Auxiliary Secretariat of Planning and Development for a period of five years. Subsequently, they will be disposed following the guidelines of the Puerto Rico Department of Health.

You will not incur in any monetary cost, nor will you receive any compensation for your participation.

Your participation is completely voluntary, and you will have the right to abstain or withdraw at any
