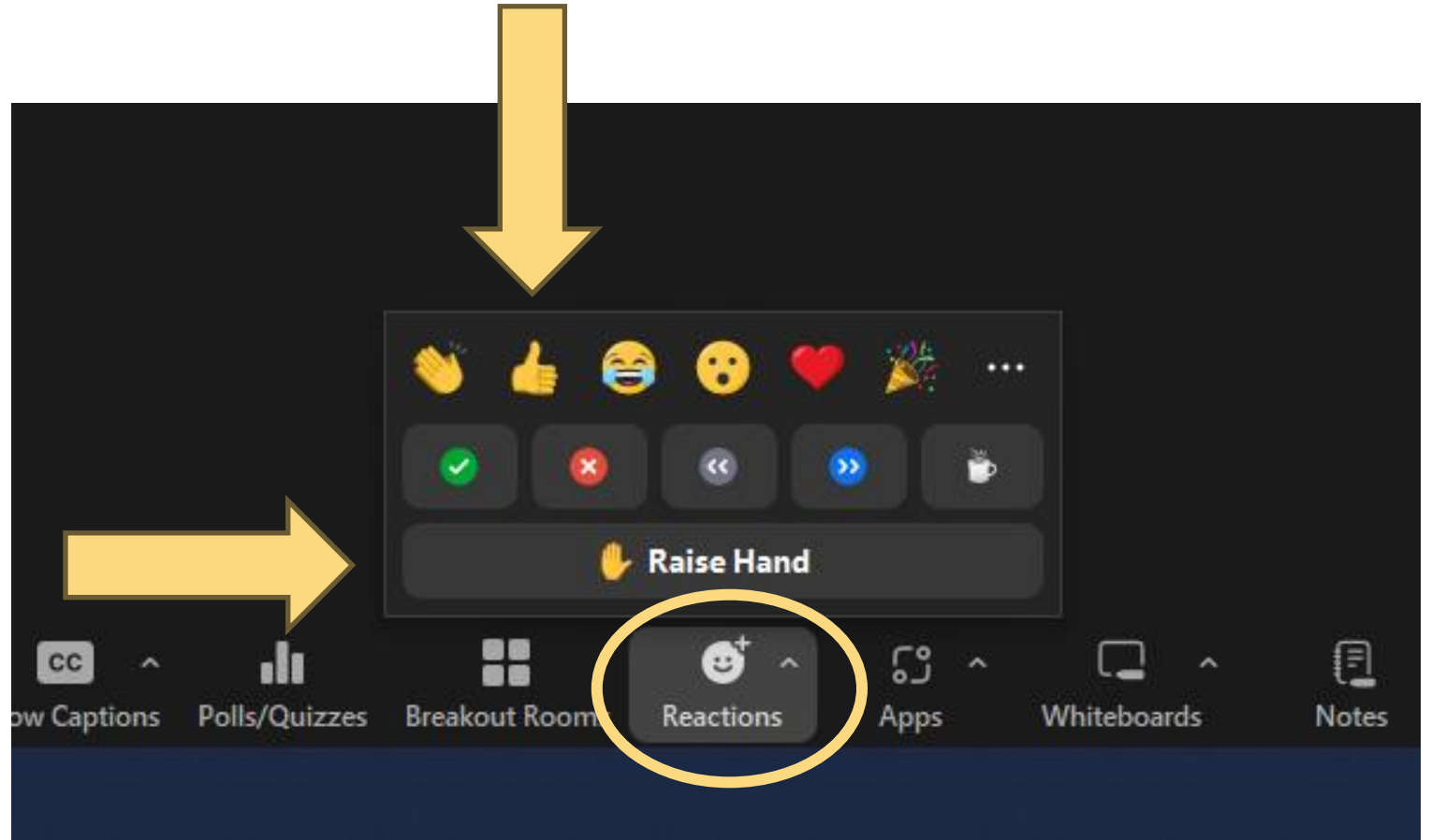

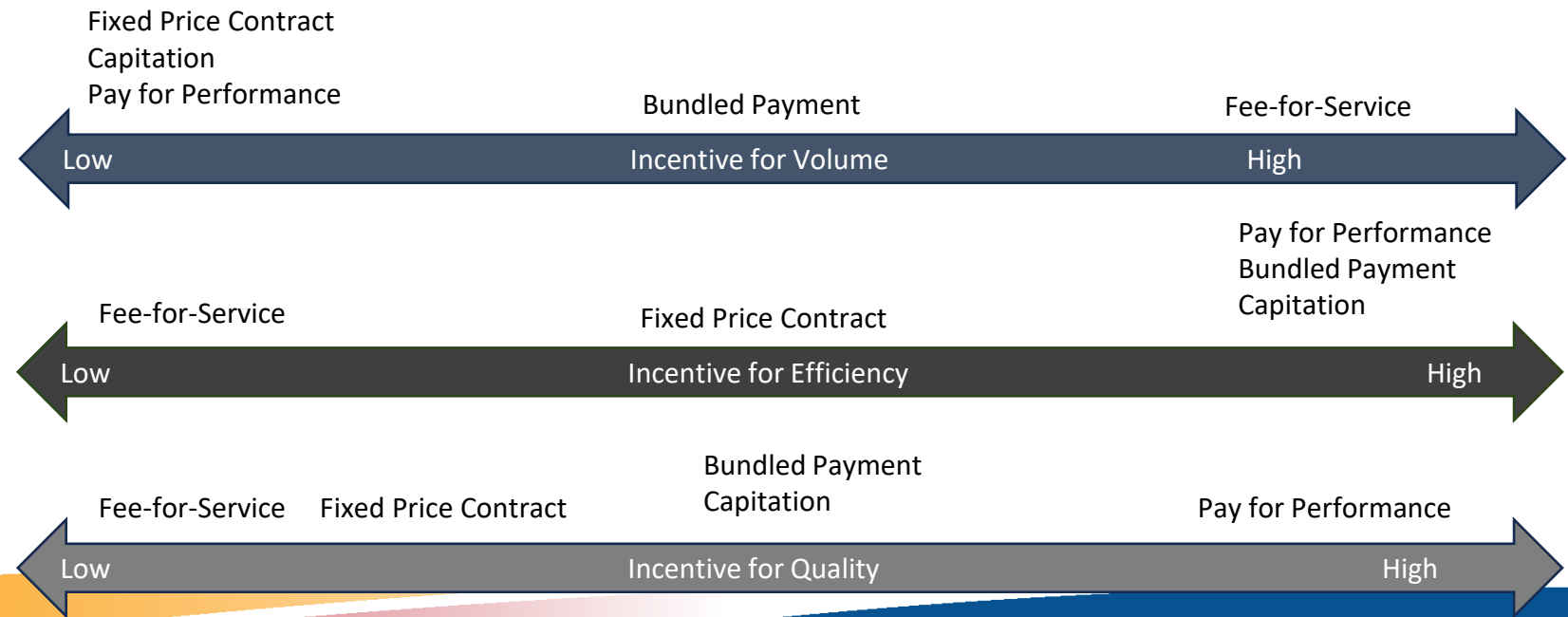

# Payment Models

Feature	Fixed Price Contract	Fee-for-Service	Bundled Payment	Capitation	Pay for Performance
Financial risk to CBO	Low	Low	Medium	High	Medium
Financial risk to payer	Low	High	Medium	Low	Medium
Complexity for parties to establish price	Low-Medium	Medium	High	High	Medium-High
Cost/complexity of billing	Low	High	Medium	Low	Medium-High

How many data systems do you use to conduct your work?



**57.3%** of contracting CBOs submit or report data through a health care partner's system

**16.8%** of contracting CBOs access data and **13.1%** report data through an HIE, HIN or CIE

**46.0%** of contracting CBOs access data through a partner's system

**28.7%** of contracting CBOs enter data into multiple systems so they can have access to data

CBOs use a median of **3** data systems to conduct any funded or contracted work

**23.4%** of CBOs are receiving service referrals from social care referral platforms (but the referral data they receive can be problematic)
